The GIRG-19

 International Association of Oil & Gas Producers (OGP) formed the Global Industry Response Group (GIRG)

 To improve industry capability to prevent and respond to a major well incident

Three GIRG sub-groups were established to focus on

Prevention (Well Engineering Design)
Intervention (Capping & Containment Team)
Response (Oil Spill Response Team)

The Oil Spill Response subgroup has so far put forward
19 key recommendations



Oil Spill Response

Global Industry Response Group recommendation upon No. 465 **Any 2011**

GIRG 19 – Recommendations focused on enhancing response capabilities

Asia – Growing Risk Profile

- One of the most biologically diverse region of the world
- Accelerated economic growth and social progress
- Increased energy demands
- More Exploration & Production activities in the region
- Increased Risk Activities and Assets

Increased Activity – No Increase in Response Capability





Preparedness Policies

- Preparedness levels have seen some progress over the last few decades
- But arguably less matured compared to other regions



Preparedness Policies

- A wealth of policy and framework
- Policies not easily accessible
- Updates difficult to obtain
- Lack of transparency



- Reluctance to use dispersants
- Mechanical Recovery is still the preferred option
- Local Products
